**Equine Activity Release and Hold Harmless Agreement
For the 2021 North Carolina Ranch Horse Show Series
Cavvietta Quarter Horse & Cattle Company**

I, _____, the undersigned have read and understand, and freely and voluntarily enter into this Release and Hold Harmless Agreement with Cavvietta Quarter Horse & Cattle Co. (Company), and in consideration for my presence and/or participation in activities on the property operated by the Company understand that this Release and Hold Harmless Agreement is a waiver of any and all liability.

1. I understand that the Company operates a working farm and specifically acknowledge the attending inherent risks contained therein. I further acknowledge the potential dangers that I could incur in mounting, riding, walking, boarding, feeding said horse; including, but not limited to: any interactions with other horses; and other parties on the premises. Understanding those risks I hereby release that Company, its officers, directors, shareholders, employees and anyone else directly or indirectly connected with that Company from any liability whatsoever in the event of injury, loss, or damage of any nature (or perhaps even death) to me or anyone else caused by or incidental to my electing to mount and ride a horse owned and/or operated by Cavvietta Quarter Horse & Cattle Co.

2. I understand and recognize and warrant that this Release and Hold Harmless Agreement, is being voluntarily and intentionally signed and agreed to, and that in signing this Release and Hold Harmless Agreement I know and understand that this Release and Hold Harmless Agreement may further limit the liability of equine professionals as a result of any activity, whatsoever, involving an equine, including death, personal injury and/or damage to ~~persons~~ or property.

3. I recognize and agree that I know which equine professional(s) I will be working with, and acknowledge that I agree said equine professional(s) has/have made reasonable and prudent efforts to determine my ability to engage in the equine activity, and has/have sufficient knowledge of my equine and horseback riding skills as to relieve, release and hold harmless said equine professional(s) from any continuing duty to monitor my equine activities, if applicable.

4. I further voluntarily agree and warrant to Release and Hold Harmless the Company and/or this (these) equine professional(s) from any liability whatsoever, including, but not limited to, any incident caused by or related to negligence, relating to injuries known, unknown, or otherwise not disclosed; including, but not limited to, injuries, death or property damage from: mounting; riding; dismounting; walking; grooming; feeding; use of horse barn, paddock, trails or horse ring, in any capacity; falling off horse whether horse is bucking, flipping, spooked; or my failure to understand or abide by any equine professional's directions relating to my riding or otherwise use and control, or lack thereof, of my horse or the horse to which I have been assigned.
