I further acknowledge the potential dangers that I could incur in mounting, riding, walking, boarding, feeding said horse; including, but not limited to: any interactions with other horses; and other parties on the premises. Understanding those risks I hereby release that Company, its officers, directors, shareholders, employees and anyone else directly or indirectly connected with that Company from any liability whatsoever in the event of injury, loss, or damage of any nature (or perhaps even death) to me or anyone else caused by or incidental to my electing to mount and ride a horse owned and/or operated by Cavvietta Quarter Horse & Cattle Co.
